

PROPOSED WORDAGE CHANGES FOR BY-LAWS

**Article III – Section 2. Add the following at the end of Section 2. : Dues are not refundable. All members will receive an electronic subscription to the newsletter. Any member wishing to receive a mailed paper copy of the newsletter will pay an additional \$10.00 per year.**

Article IV – Section 3. At the end of current wordage add: When deemed appropriate, the President may conduct meetings electronically.

Article IV – Section 5. Change the sentence to read: Each outgoing Board member must turn over monies and records to incoming Board members by the first meeting of the new term.

Article V – Section 1. A: Remove the word Treasurer from the last sentence.

Article V – Section 1. B. To be renamed Sub-paragraph C.

**Article V – Section 1. NEW Sub-paragraph B to read: The Treasurer shall be appointed by the Executive Board.**

Article V – Section 2. B. Edit to read: Elected officers may not serve more than two consecutive terms in the same office.

Article V – Section 3. To be removed entirely.

Article VII – Section 1. B. To read: Appoint committee heads.

Article VII – Section 1. D. Remove the words recording secretary and replace with Secretary.

Article VII – Section 4. A. Edit last sentence to read: All monies of the Guild shall be deposited in an account under the name of the Guild.

Article VII – Section 4. B. Last sentence to read: If the Board fails to make such designation, the second authorized signature shall be the President.

Article VIII – Section 1. First sentence to read: There shall be the following committees: Art Walk, Audit, Budget, Challenge, Historian, Hospitality, Membership, Newsletter, Nominating, Program, Retreat and Special Speakers.

**Article VIII – NEW Section 2. The Art Walk Committee is to support the Guild’s annual exhibit in conjunction with the city’s spring Art Walk, sponsored jointly by the Downtown Bowling Green Organization and the Bowling Green Arts Council. The Art Walk sponsors’ liaison to the Guild shall be the ex officio chair of this committee and a co-chair from among guild members shall be appointed by the President. Additional committee members from the guild may be appointed by the President. Members shall serve a one-year term, renewable at the discretion of the President.**

All additional Section numbers to Article VIII will advance by 1 number.

Article VIII – Section 2 – now 3: Change January to February in second sentence. Change or to and in the last sentence.

Article VIII – Section 6 – now 7: Edit to read: The Hospitality Committee shall consist of at least one member who is responsible for greeting and welcoming visitors at the meetings, as well as arranging for refreshments as needed.

Article VIII – Section 7 – now 8: Replace the words membership packets with membership information.

**Article IX – NEW Section 4. Meetings will be cancelled in the event that a Level One Snow Emergency is declared for Wood County at the time of the meeting. An email regarding a cancellation will be sent when possible. The Level One information would be available on TV and radio stations as well as online. Members should check the media for pertinent weather alerts for their own counties/communities.**
